Current accounts will be automatically transferred for service to the Branch № 28 of JSC "PIRAEUS BANK ICB", located at: Odessa, st. Bunina, 33 from **01.10.2020.**

If you are not interested in further cooperation, we kindly ask you to contact the specialists of the branch till September 30, 2020 to resolve issues related to the termination of your servicing.

If you are the owner of a current or pension account (including a payment card) - you can apply for closure of such an account and receive the current balance of funds together with all accrued interest

If you are the owner of a term bank deposit in Piraeus Bank, you will be able to receive your deposit upon its expiration together with the accrued interest in the branch №28 of JSC "PIRAEUS BANK MKB", located at - Odessa, st. Bunina, 33 or early break the contract (for all types of products) without the application of penalties by the bank and with payment of all accrued interest from the date of placement of the deposit until the date of its early breaking
